6. Award Qualification

- (1) To qualify for club championship and trophy events, a competitor shall compete in not less than one quarter of the club winter events for which their club membership entitles them.
- (2) To qualify for club representation as a member of a specific open or age group team, a member shall compete in not less than one quarter of the club winter events for which their club membership entitles them.
- (3) To qualify for a club championship award, a member shall have already competed in that distance during that winter season.
- (4) Where a member is unable to meet the forgoing qualification requirements, the Committee may approve such cases, where the reason includes situations such as, but not necessarily limited to, absence for work, holidays, illness, injury or having a residence significantly distant from the Perth metropolitan area.
- (5) Competitors not meeting the above qualification requirements may compete although being ineligible for any award.
- (6) Notwithstanding the above qualifying requirements, participants in the following walks are not required to be members: Father's Day and Mother's Day novelty walks; Don Rapley Trophy (men) and Presidents Shield (women) 10K.
